2] **AND WHEREAS**, in accordance with Chapter 3 of the said Rules of the University, the Internal Committee at the Hinjewadi Campus/ Location of Symbiosis International (Deemed University), Pune was constituted vide Notification No. SIU/ U-28/ 826 dated 24<sup>th</sup> June, 2019;

3] **AND WHEREAS**, the tenure of the Internal Committee at the Hinjewadi Campus/ Location of Symbiosis International (Deemed University), Pune constituted vide Notification No. SIU/ U-28/ 826 dated 24<sup>th</sup> June, 2019 and reconstituted from time to time has come to an end on 23<sup>rd</sup> June 2022;

Head-Student Affairs/ One of the Members of the Committee from amongst the Non-Teaching employee shall act as Member Secretary of the Committee


